The Board of County Commissioners of Washington County, Maryland, will accept sealed bids for the **Colonel Henry K. Douglas Drive Extension, Phase I & II, Contract No. RD-CD-269-10**. Bids will be received and time-stamped in the **Division of Engineering**, County Administrative Annex, 80 West Baltimore Street, Hagerstown, MD 21740-6003, until **2:00 P.M. Wednesday, November 7, 2018** after which time they will be publicly opened in a conference room of the County Administrative Annex. Bids received after this time will be returned unopened.

The **Colonel Henry K. Douglas Drive Extension, Phase I & II** is generally described as follows: **new construction of approximately 1400 lf. of roadway with both porous and traditional asphalt pavement for a four lane closed section roadway with additional turn lanes. Grading, storm drain inlets and culverts, and precast concrete stone-filled gravity retaining walls as well as pervious concrete sidewalk and w-beam traffic barrier is included with the design. The road connects to the MD 65, Colonel Henry K. Douglas Drive (west) intersection and includes above ground intersection signal improvements as well as limited restriping within the State Highway.**

All work on this project shall be done in accordance with the MSHA Specifications. This Project Classification is Cost Group Letter Class "E," \$2,500,001 to \$5,000,000.

Qualified Contractors may obtain plans and specifications from the **Division of Engineering**, County Administrative Annex, 80 West Baltimore Street, Hagerstown, MD 21740-6003, **between 7:30 a.m. and 4:30 p.m.**, (Telephone 240-313-2460), upon a **NON-REFUNDABLE fee of Seventy Five Dollars (\$75.00)** for each complete set. For mail requests, which must be made in writing, an additional **Twenty-five Dollars (\$25.00)** per set must be included, along with a full mailing address, contact person with e-mail address, and phone / fax number. All checks for bidding documents shall be made payable to the **Washington County Treasurer**. If a Contractor wishes to supply a FedEx or UPS account number in lieu of the additional mailing fee, this is acceptable. Payment must be received before bid documents can be mailed.

Bid security in the form of a cashier's check, certified check, or bid bond in the amount of five percent (5%) of the total bid amount shall be submitted with Contractor's bid. Bid bonds shall be made payable to the Board of County Commissioners of Washington County, Maryland. The successful Bidder will be required to furnish satisfactory Payment and Performance Bonds for the full amount of the Contract. Bids shall be executed on bid forms provided with the bidding documents in accordance with the Instructions to Bidders.

A Pre-Bid Conference for the project will be held **Wednesday October 10, 2018 at 11:00 A.M.** local time in a conference room at the **Division of Engineering, County Administrative Annex, 80 West Baltimore Street, Hagerstown, MD.** All prospective Bidders are encouraged to attend.

Washington County shall make positive efforts to utilize Disadvantaged Business Enterprises for its supplies and services and shall allow these sources the maximum feasible opportunity to compete for contracts.
